FINES AND COST

Be it Ordained by the Mayor and Council of the Town of Vincent, Alabama Ordinance 2003-002 setting fines and cost for Vincent Municipal Court to read as follows:

In compliance with Rule #20 of the Rules of Judicial Administration of the Administrative Office of Courts and in accordance with 11-47-7.1 of the Code of the State of Alabama the following schedule of fine and costs will be effective upon the adoption and publication as required by law.

SECTION 1. This schedule shall be displayed in the office of the Court Clerk/Magistrate.

SECTION 2. The Court Clerk/Magistrate may take guilty pleas on the fines listed below marked with an asterisk.

SECTION 3. This schedule of fines will be posted in the Police Department.
